- Focus on supply chain and system failures.
- Surplus is created in thinking in network configurations, instead of thinking in territorial configurations.

# Characteristics of the Secure Lane

- Information-sent security chain, aimed at the prevention of chains- and system failures.
- From reactive to proactive (Stop Crime!).
- Cooperation between public and private partners.
- Organize collective (regionally) security by private public partners.
- The camera's on the parkinglots are connected to the businessparks.
- Live camera surveillance from the Regional Monitor Room.
- Direct connection and transfer of info to the control rooms of Police, Fire department and ambulance.

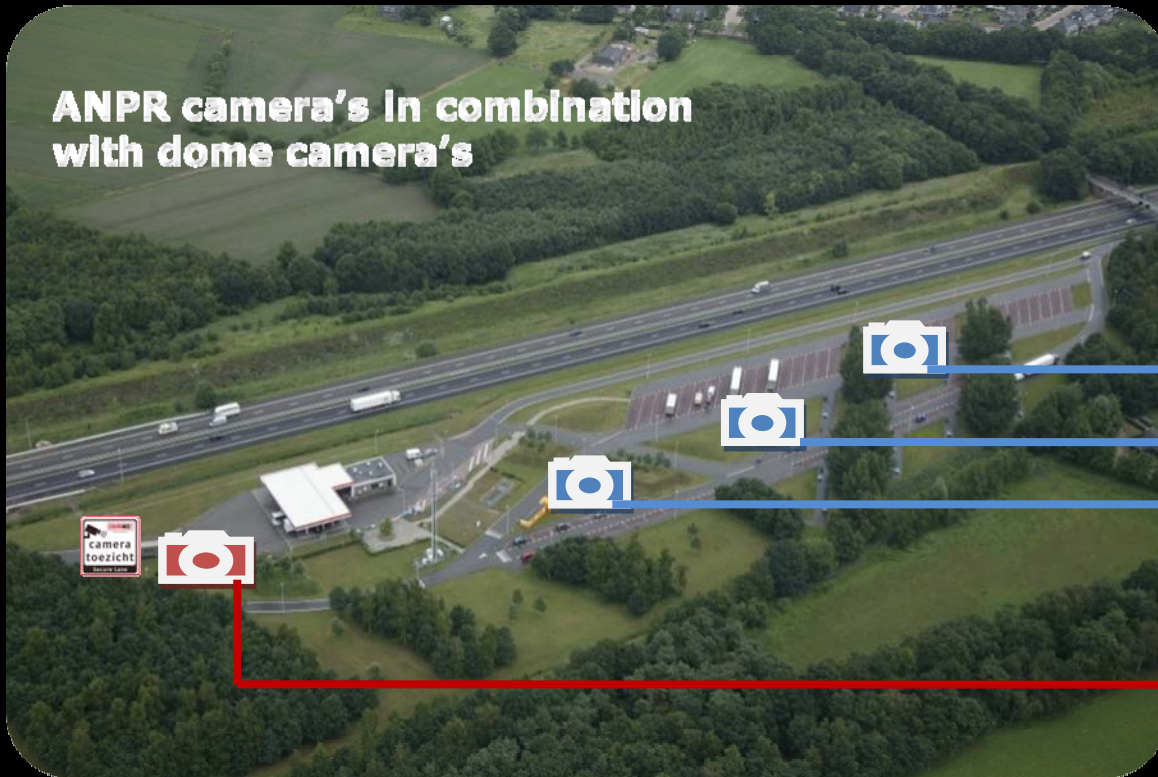

# The results of de Sucure Lane.



- The public and the private domain is safer.
- No information is unnecessarily lost between the public and private partners.
- The Regional Monitoring Room (RTR ®) is the central node (Detection and Analysis) and is complementary to private call centers and the joint control room of police, fire and ambulance (Choice and Coordination Actions).
- Cooperation is efficient (roles are clear), effective (both prevention and law enforcement) and low costs (for governments and businesses).
- Chain and system failures are reduced to a minimum.
